MAINTENANCE AGREEMENT

A. PREVENTIVE MAINTENANCE AND INSPECTIONS, SEMI-ANNUALLY.

It is hereby agreed that we will provide a qualified technician to inspect your heating system in the fall/winter and air conditioning system in the spring/summer for proper operation to insure that it's in the best possible condition and operating at peak performance. Inspections shall be made semi-annually and will include the following:

B. ACCESSORIES.

Any attachments to the heating and air conditioning system such as humidifiers, air cleaners or the like thereof, must be listed to become part of this agreement.

C. PRIORITY SERVICE

As an agreement customer a priority response will be granted over non-agreement customers if your systems should require service. You will also receive 10% off any parts needed.

D. AUTOMATIC SCHEDULING

As an agreement customer you will be notified by postcard when preventive maintenance is required to be performed. An appointment, mutually agreed upon, will be scheduled when you call our office.

E. PARTS & LABOR

All labor cost for the preventive maintenance procedures shall be included under this agreement. Standard filters shall be supplied by this contractor at no further cost to the agreement customer. Any repairs required during inspection shall be made only after being authorized by the customer and shall become an additional charge over and above the cost of this agreement.
